Hi Jo-Anne!

Dominican! How lucky!! Thank you so much for reaching out regarding Amber attending the Exeter RAM Rodeo. We had to confirm a few scheduling details - so I apologize for the delay in getting back to you. I am pleased to share that Amber is available - with a few limitations - for this appearance. As she is going to be back on the Heartland set at this time, she is typically advised to not take on too many distant appearances. She films late Friday and early Monday morning, but is more than happy to fly in and out to appear at the Sunday performance at 1pm.

The cost for the appearance is \$3000 + travel (and due to the time constraints, we request that this is a business flight from the London airport). Typically, I would arrange her travel and include it as an expense on her invoice to you.

We have a pretty good system in terms of security, we would request a private room/even a trailer that she can access tucked out of sight. We request 1 or 2 people who can assist with travel to the ring and back to the 'green room'. Ross is very good at this process and typically reco's one of his men that we are familiar with. That shouldn't be an issue.

For a signing, Amber loves to do this, however, with the time constraints and depending on the timing of her flight home, we would suggest limiting the signing to 150 people. This can be accomplished by a wristband system - or even ticketed. I have lots of suggestions if you are interested in that. We would require a table and the same 2 personnel to help with line management. Amber and I have mastered the efficiency of meet & greets and should be able to handle the table and front of the line to keep things moving ourselves - all details we can discuss over a call if you were interested. Also, I wanted to suggest in the past, Amber has brought 5X7 postcards that we design for the event that she will hand out at the signing and if time allows - around the ring on horse back at the end of the rodeo.
