Notes

- Engaging and interactive discussion with the Rodeo Committees within the RAM Rodeo circuit
- Great networking opportunity, generating excitement and enthusiasm throughout the group
- Overall comments on the 2018 rodeo were excellent new format was very well received
- B & W Hitches are a new corporate sponsor this year Marks are not involved
- Long discussion regarding admission fees many rodeos have increased and have noticed no impact to attendance – suggest to promote advance ticket sales

- Suggest \$25.00 for adults, \$15.00 for youth, \$5.00 for child and \$70.00 for a family (2 adults, 2 youth and additional youth would be \$10.00 child free). Basically the only increase in cost is to the adult admission
- Advance tickets they save \$5.00 each and a child is free
- Canadian Cowgirls are not in the show this year
- In place of Canadian Cowgirls will be Mounted Shooting authorization and permits will be required through the Municipality as well as site inspections – information was shared at the last meeting – Manager Scott Currie is seeking approval and retaining necessary information required
- New Pick up race locals can compete sign up 10 days in advance more information to follow complete with media release
- Exeter Rodeo was recognized at the Awards Banquet and Chair Nickles and Fields accepted the plaques
- Exeter is the longest running Rodeo on the RAM Circuit
- Lots of positive comments from the competitors regarding the Exeter Rodeo event
- Other notes spoke with Ty Baynton regarding Entertainment for Saturday pm Tailgate and Evening – he has a previous commitment for Saturday evening however would be happy to perform at our Tailgate on Saturday – we tentatively booked him for a cost of \$500.00. This needs to be confirmed and staff complete contract
