6. O.P.P. Report

- Detailed report for January was distributed prior to the meeting for review and to allow for effective discussion at the Board meeting
- Inspector Younan provided a comprehensive overview and explanation of the report for the month
- Further clarification and highlights were provided for each category
- Traffic stats increased R.I.D.E. programs over last year
- 67 E-Tickets were issued and 52 warnings
- Focus patrol continues surrounding High Schools in Huron County focus on traffic safety and enhanced police visibility
- Proactive policing in area schools, as well as local arena facilities during activities and hockey games
- Due to police presence at the arena, an incident was reported as the officer had been in attendance the week prior – concern was expressed over an individual attending and public safety
- No significant media releases addressed
- 291 occurrences in South Huron
- Canadian Tire Two Theft occurrences were reported to police in January 2023 one call for service resulted in charges being laid and the second call for service involved significant follow-up by multiple offices and a regional OPP analyst, but unfortunately there was no suspect identified
- Investigations related to Canadian Tire have been significantly improved over the past year
- Construction equipment and tools have become very hot theft items throughout the County
- When stolen property is recovered, it can be challenging at times to locate the rightful owner as serial numbers are not always recorded
- Two search warrants were issued in the County
- Property crimes clearance rate is 17.9% to date
- Calls for Service similar to the 2022 hours for the same time frame
- Chair Dietrich noted that the 2023 hours are even much lower than that of 2021 which is a great sign Contract costing is determined on a 4 year average
- S/Sgt Ian George will be leaving on March 05, 2023 with Staff Sgt Ryan Olmstead replacing him in the permanent role
- Member Frayne noted the number of R.I.D.E. programs conducted and thanked the officers for their commitment

 Chair Dietrich thanked Inspector Younan for reviewing the OPP Report, for what he and his Officers do for Huron County and for their commitment to policing – please pass on our thanks to the Officers on behalf of the Board







- Bail Reform DRAFT Motion
- Lengthy discussion with the membership took place discussing various options to endorse the draft motion prepared by Waterloo Regional Police Services Board

Motion - Ian McSweeney/Lynn Silverton

"That following a presentation on bail reform during the first part of the meeting (Chiefs and Boards), and discussion of a request for support from the Waterloo Regional Police Services Board of its motion (the "Motion") calling on the Provincial and Federal governments to collaborate to enact sector-wide reform to Canada's bail system (including broadening the application of the reverse onus protocol and ensuring that provincial bail policies and directives integrate these new proposed legislative changes), it is recommended that Zone 5 boards which support the Motion:

- adopt the Motion;
- write a letter to the Federal and Provincial governments (addressed the same as Waterloo's letter) in support of the Motion copying their local MPs and MPPs;
- write a letter to the OAPSB encouraging OAPSB support of the Motion;
- encourage their Municipal Councils to adopt the Motion and communicate their support to the Federal and Provincial governments, as well as local MPs and MPPs; and confirm in writing to the Zone 5 executive, authorization to contact the Federal and Provincial governments in writing to express Zone 5 support for the Motion."
