- Snow storm caused havoc over the festive holiday happy to report that there were no major or fatal collisions despite the significant snow fall
- Traffic report is self-explanatory
- RIDE programs 883 R.I.D.E. programs were conducted in 2022 compared to 690 the previous year
- Etickets and warnings continue roadside
- Focus Patrols continue relating to High Schools in Huron County traffic safety and enhanced police visibility are part of this focus – will continue until the end of school year
- Reviewed Media Releases
- Initiatives in Huron County recognizing that some families in our communities may be struggling at this time of year – Cram a Cruiser event – Annual Hockey Game – Fire vs Police – looking to expand events/initiatives in the future to support area families
- Expanded on the OPP Warrant executed in Exeter over \$18,000,00 worth of stolen property and drugs seized
- Gas drive offs continue to be an issue

- Clearance rates extremely impressed with results year over year
