- Detailed report for April was distributed prior to the meeting for review and to allow for effective discussion at the Board meeting
- Inspector Younan presented the report and provided a comprehensive overview for the month
- Huron County leads southwestern Ontario in R.I.D.E. programs proud of this initiative
- Proactive R.I.D.E. programs can lead to more convictions surrounding drinking and driving
- Further clarification and highlights were provided for each category and were explained for the benefit of the new Board member
- New handbooks will be distributed that explains and provides a great overview of the Billing Model
- Collision Reduction Strategy Main Street North and Thames Road
- Targeted Offences Distracted Driving and Disobeying Traffic Signal until April 10th resulted in 8.5 hours dedicated patrol, 1 charge, 1 warn and no collisions reported
- Airport Line and Dashwood Road from April 24 May 08, 2023
- Targeted Offences Speeding, Distracted Driving, Fail to Yield/Stop On-going
- Roadside E-tickets continue 123 E-Tickets were issued and 71 E-Warnings
- Easter long weekend target seatbelt campaign 30 seat belt charges were laid 218 offenses in total
- OPP took on the Central Huron Secondary School senior students in a friendly game of ball hockey on April 27, 2023
- Proactive engagement with students continuing to establish partnership and engagement
- Strategy is to move this type of initiative and partnership across all Huron County schools
- The Huron County Food Bank received a load of non-perishable food items which were collected from the students and Officers
- Great opportunity to interact and build positive relationship with local youth in a fun way
- Theft under gas drive offs continue to represent approximately 99% of theft under appears to be a common theme in South Huron

- Fraud bank related bank accounts accessed fraud prevention education sessions continue to be delivered in retirement homes, to church groups and to any other interested groups
- Property crimes Huron County Detachment clearance rates are far above the regional and provincial averages
- Criminal record checks are all completed on line
- Call for Service Bill Summary condensed version circulated bottom line year to date/weighted hours vs last year – looking for a decline in the number year over year – 4 year average trending downward will result in a decrease in billing and cost per property
- Laura questioned if the break and enters were to commercial properties or residential all 3 were commercial properties during this reporting period – construction is a hot target
- Traffic complaints almost doubled explained that this is due to the introduction and reporting of roadside e-tickets – report summary gathers the information and lumps into the traffic complaint category

Focused Patrols

Focused Patrols continue relating to High Schools across Huron County. Officers continue to dedicate time to vehicle and foot patrol around South Huron High School to enhance police visibility and engage in positive interactions with our local youth.

Collision Reduction Strategy: Through analysis of motor vehicle collisions for the past five years, hot spot locations and causal factors of collisions have been identified in order to effectively and efficiently deploy policing resources to reduce motor vehicle collisions. Focused Patrols have been created to target identified hot spots in an attempt to reduce motor vehicle collisions. In the Municipality of South Huron since the implementation of the Collision Reduction Strategy there has been a 15% decrease in motor vehicle collisions.

Media Releases

HURON OPP COLLISION REDUCTION STRATEGY IS WORKING

(HURON COUNTY, ON) - The Huron Detachment of the Ontario Provincial Police (OPP) has conducted a five-year collision analysis and is implementing a strategy to reduce the number of collisions by focusing on areas of concern.

Huron County OPP has seen a significant increase in Motor Vehicle Collisions over the past five years (2017 - 2022). Through a detailed analysis the detachment area has noted a **25%** increase in Property Damage collisions, a **27%** increase in Personal Injury collisions and a total of **46** fatal collisions.

During the month of April 2023 officers focused on enforcement at two intersections that have been problematic in the past:

#1: Dashwood Road at Airport Line in South Huron

- Seven speeding charges laid, two seatbelt charges and only one car vs deer minor collision near the intersection.


#2: Bluewater Highway at Saltford Road in Ashfield-Colborne-Wawanosh Twp.

- Three speeding charges, one warning and zero collisions.

This is a 38% reduction in collisions at these locations compared to the same time frame in 2022.
