#### 5. Business Arising from the Minutes

5.1 Expressions of Interest for Exeter Rodeo Committee Voting Members

#### 5.2 Inflatables

S. Nickles shared regarding renting inflatables. Prices vary for the various companies. Big obstacle courses and the bigger units are anywhere from \$400.00 to \$450.00 a day plus \$15 an hour additional as most companies will require a supervisor to accompany the inflatable. Smaller units range from \$200.00 to \$350.00. Depending on how much is decided on to spend it can cost \$3,000.00 to \$10,000.00. The \$3,000.00 to \$5000.00 range would likely provide two big units, possibly three little ones and will provide a supervisor as well. As a side note, it is not known if a supervisor is required for each of the big units or if just one supervisor will be sufficient for the two. J. Fields will make enquiries at the rodeo event she is attending to get further details. A budget will be determined at a later date.

# 5.3 Meeting with Staff

J. Dietrich and J. Fields met with staff from the Community Services department to touch base on the 24th and 25th rodeo. They spoke about what the committee does and confirmed having a good working relationship with staff. They discussed single sourcing, that the Committee is happy with Rodeo Management Group and want to continue partnering with them. J. Fields is compiling a list of reasons for staying with the rodeo management group and will meet again with staff. J. Fields shared about the \$50,000.00 rodeo budget process, sharing that it's typically a line item in the Municipal budget under the Community Services department showing no profit or loss. A summary of the revenue and expenditures is done and shows a net balance of zero.
