#### **OPP INVESTIGATING FATAL COLLISION INVOLVING A CYCLIST**

#### Investigation Leads To Charges For Driver

(SOUTH HURON, ON) – Huron County Ontario Provincial Police (OPP) officers have been investigating a fatal collision that took place near Crediton in June 2022.

On June 29, 2022, at approximately 9:50 p.m., Huron County OPP, Huron County Paramedic Services and the South Huron Fire Department responded to a report of a cyclist that was struck by a vehicle east of Crediton, on Crediton Road (Huron County Road #10).

A 17-year-old male cyclist from South Huron was pronounced deceased at the scene.

Members from the West Region OPP Traffic Incident Management & Enforcement (TIME) Team attended the scene to assist with the collision investigation.

As a result of an investigation conducted by the Huron O.P.P., the driver of the involved vehicle has since been charged.

Heather RICHARDSON, 41 years of age, from South Huron has been charged with:

- Operation While Prohibited
- Driving While Under Suspension

The accused has been released from custody with a Goderich court date in January 2023.

#### **OPP WARRANT EXECUTED IN EXETER**

Over \$18,000 Worth of Stolen Property and Drugs Seized

(SOUTH HURON, ON) – A stolen property investigation conducted by the Huron-Perth Ontario Provincial Police (OPP) Community Street Crimes Unit (CSCU) has culminated this week in a seizure of various stolen property, Cocaine, Fentanyl and Methamphetamine.

On Tuesday, December 06, 2022, members from the Huron-Perth OPP (CSCU), Huron County OPP Crime Unit, and West Region Emergency Response Team (ERT) executed a search warrant at a residence on William Street in Exeter.

As a result of the execution of the search warrant, police located and seized a large amount of stolen property including various tools, a tankless water heater, home furnace, generator, new home fixtures, antique coins, cash, and a replica handgun. Police also seized quantities of suspected Fentanyl, Methamphetamine, and Cocaine.

The combined estimated value of the seized stolen property is **\$13,500**. The combined estimated street value of the seized controlled substances is **\$5,100**. **\$625** in Canadian currency was also seized.
