





Municipal Class Environmental Assessment for the
Water and Wastewater Master Plan

The Study

The Municipality of South Huron has undertaken a Water and Wastewater Master Plan Update. This study was conducted in accordance with the requirements of Phases 1 and 2 of the Municipal Engineers Association Municipal Class Environmental Assessment process for Master Planning. The Master Plan is following Approach #1.

This Master Plan Update aimed to develop and evaluate the optimal water and wastewater servicing strategies to support the needs of existing users and to support potential population and employment growth within the Municipality. This is a critical component in the integrated planning process and will provide the framework and vision for the water and wastewater servicing needs for the Municipality of South Huron. The Master Plan Update forms the basis for future, more detailed investigations for projects that are subject to the Environmental Assessment Act.
