Please be advised that Council of the Corporation of the Municipality of South Huron intends to pass an amending by-law to remove a holding zone for the above-described lands at their regularly scheduled Council meeting on:

Effect of the Removal of the Holding Zone

The purpose of the proposed zoning by-law amendment is to remove the -h holding symbol from the lands described as Lots 1 through 5 in the attached draft M Plan dated January 24, 2024 (otherwise referred to as Phase 2 of Plan of Subdivision File # 40T10001). The subject lands are presently zoned R1-H and R1-24-H in the South Huron Zoning By-law. Removal of the holding symbol will allow structural development to occur in accordance with the provisions of the zoning by-law and the applicable subdivision agreement.
